### **2.0 UPPER AGE LIMIT AS ON 01.01.2026:**

**Trainee Engineer/Officer – I:** The age limit should not be more than 28 years for General&EWS candidates as on 01.01.2026

- i.) Candidates seeking age relaxation will be required to attach copy of necessary certificate along with application and submit in original in case of selection or provide at any subsequent stage of the process for verification.
- ii.) The EWS/Caste/Disability Certificate should be strictly in the format available on the BEL website failing which, candidates will be considered under ‘General’ category, provided they are otherwise meeting all other criteria stipulated for General Candidates.
