- IV. There shall be an initial assessment (probation) period of three months from the date of first engagement.
- V. The cut off age, qualification, experience etc. will be last date of registration, i.e **07- 02- 2026**.
- VI. Relaxation for SC/ST/OBC and Physically Handicapped will be given as per Government guidelines, subject to submission of Caste /Disability Certificate issued by the Appropriate Authority in support of his/her claim.
- VII. OBC Certificate with Non-Creamy Layer and EWS issued by appropriate authority of Govt. of NCT of Delhi, only will be accepted for the Current Financial Year.
