(A)	<b>Economically weaker section (EWS) :</b> All the terms and conditions in respect of reservation for Economically Weaker Section (EWSs) in civil posts and services in the Govt. of India shall be regulated in terms of DoPT OM No. 36039/1/2019-Estt(Res.) dated 19.01.2019 and OM of even no. dated 31.01.2019 as amended from time to time. Candidates belonging to the EWS category in terms of the above-mentioned OMS are required to produce the Income and Asset Certificate issued by Competent Authority, in the prescribed attached format (Annexure-A) at the time of document verification. The last date of receipt of applications i.e. 08.04.2026 shall be treated as the crucial date for submitting the Income and Asset Certificate by the candidate. Non-submission of such certificate shall be treated as disqualification.
(B)	<b>Age Limit: -</b>
1.	The crucial date for determining the age limit shall be the last date of receipt of application i.e. 08.04.2026.
2.	No age relaxation will be given to SC/ST/OBC (Non-Creamy Layer) candidate applying for the Unreserved posts as per Govt. of India order No.36011/1/98/Estt(Res.) dated 01.07.1988 as amended from time to time.
3.	The age relaxation to SC/ST/OBC/(Non-Creamy Layer)/PwD/Ex-Servicemen etc. shall be considered as per the DoPT OM No. DoPT-1667569393892 dated 06.09.2022 as amended time to time.
4.	Age concession of 5 years are allowed to Departmental Candidates and Central Government employees for appointment by direct recruitment subject to the usual condition that the Group post to which direct recruitment is being made are in the same line or allied cadres and that a relationship could be established that service rendered in the post will be useful for efficient discharge of the duties in other categories of posts.
(C)	<b>Others:-</b>
1.	No TA/DA will be paid to attend the Written Test/Skill Test and the candidate will have to make their own arrangement.
2.	Date, time and venue of the Written Test/Skill Test/Interview will be communicated to the shortlisted candidates through call letter/admit cards and no enquiry/request in this regard will be entertained. Candidates are advised to visit NIB website from time-to-time on the updated status of the recruitment process.

1. **Applications shall be accepted only when submitted through online mode and when the hard copy of the online application form, along with all self-attested testimonials, certificates/educational qualifications and supporting documents, is duly sent to the Institute within the prescribed time limit. In case of non-submission of any of the above documents or if any document is found missing/incomplete, the application shall be liable to be rejected without any further notice.**

2. The post carries usual allowances as admissible to Central Government Employees of corresponding status.

3. Relaxation in age for Government Servants and SC/ST/OBC/Physically Handicapped candidates will be as per the instructions of the Government of India issued from time to time.

For Administrative Assistant: The eligible candidates will be called for the Computer Based Examination (Objective Type Multiple Choice), with a negative marking of 0.25 marks for each wrong answer. Merit list will be prepared out of the candidates obtaining the qualifying marks (minimum of 60%) in Computer Based Examination. Candidates for Administrative Assistant in the merit list will be called for skill test in the ratio of 1:5.
10. For Jr. Hindi Translator: The selection for the post of Junior Hindi Translator will be made through an Open Competitive Examination consisting of two papers – Paper-I and Paper-II. Paper-I will be a Computer Based Examination (Objective Type Multiple Choice) comprising questions in both English and Hindi, with a negative marking of 0.25 marks for each wrong answer. Evaluation of Paper-II will be undertaken only for those candidates who qualify in Paper-I by securing a minimum of 50% marks. Paper-II will be descriptive in nature and intended to assess the candidate's writing and translation skills, which are essential for this post. It will include translation from English to Hindi and vice versa, précis writing, and essay/paragraph writing in both languages. The final merit list will be prepared on the basis of marks obtained by the candidates in Paper-II only.
